

COVERING CONDITIONS 2024
JOS LANSINK HORSES BV

1. These conditions of sale apply to the semen of the stallions listed below, sold and distributed through the company under Belgian law BV JOS LANSINK HORSES, with registered office at 3620 Lanaken, Sprokkelstraat 21, registered in the KBO company register under no. 0866.148.137, hereinafter referred to as "stallion owner".
2. When placing an order, the mare owner declares having taken cognizance of the conditions and accepting the covering and payment conditions as well as the covering prices.
3. These covering conditions and prices are exclusive of VAT and apply to the 2024 covering season only.
4. Semen of our stallions (except for Cumano) is offered fresh. Please note that due to circumstances fresh semen is currently not available. In consultation, frozen semen can be sent. Semen is not sold by the straw. The sperm is sold for insemination of a mare in covering season 2024 in view of the birth of a foal in 2025.
5. The sales price for semen from our stallions is as follows:

6. The supplied semen straws are solely used by the mare owner for the specified mare and cannot be resold. The name of the mare for which the sperm is used is communicated when the order is placed. The mare owner must provide the stallion owner with a copy of the mare's studbook.
7. The recommended number of straws of (frozen) sperm to be applied may vary per stallion. Each dose contains the correct amount of straws needed for one insemination. Splitting up, passing on or selling a dose or straws is strictly prohibited.
8. If not all straws of sperm are used for the designated mare, they will remain the property of the stallion owner. The mare owner will return unused straws of sperm or submit proof of their destruction to the stallion owner.
9. Expenses for veterinarians, transport and shipment of the semen and for its delivery and dispensation are to be borne by the mare owner.
10. The cost of the health certificate is borne by the stallion owner.
11. Transport of sperm abroad is at the mare owner's own risk.
12. The sperm can also be collected from: Bullenstraat 23, 3670 Oudsbergen, Belgium.

13. The mare owner must pay the covering fee within 14 days of receiving the invoice.
14. Per mare, sperm will be supplied for a maximum of three insemination cycles in season 2024. The mare owner receives a five-month gestation guarantee. If the mare is not fertilised, this must be reported to the stallion owner using a veterinary certificate.
15. The mare owner has to return the final insemination certificate/embryo transfer certificate, signed by the veterinarian and stating the final insemination date/embryo transfer date, to the stallion owner before 30/10/2024.
16. The mare owner must provide the stallion owner with a summary of the number of successfully implanted embryos per mare, prepared and signed by the veterinarian or embryo transfer centre, by 30/10/2024 at the latest.
17. The semen of the aforementioned stallions delivered under these conditions is not ICSI-free.
18. ICSI treatment of ova with frozen semen of the stallion Cumano is subject to special conditions. Upon request, the stallion owner will send you a separate agreement for this.
19. If the mare owner would commit (attempted) fraud, the unconditional fine, apart from the covering fee, which will still be due, amounts to EUR 5,000.00 per infringement, subject to the stallion owner's right to claim a higher amount if the actually incurred damage would be higher.
20. Failure to pay the stallion owner's invoices (on time) automatically creates the obligation to pay interests at 8% per annum on the outstanding principal sum(s) and a fixed compensation of 10% on the outstanding principal sum(s) with a minimum of EUR 250.00.
21. The stallion owner may change the covering conditions and rates at any time during the covering season without further notice.
22. In the event of a dispute, the courts of the judicial district of Limburg/Antwerp, division Tongeren, have exclusive jurisdiction. Belgian law is exclusively applicable to the agreement between the parties, with the exclusion of the provisions of the Vienna Sales Convention.
